DECLARATION, UNDERTAKING, WAIVER AND INDEMNITY TO BE COMPLETED AND SIGNED BY EVERY COMPETITOR, ENTRANT, RIDER, DRIVER.

I understand and confirm that, should I at the time of this racing event be suffering from any disability whether permanent, temporary or otherwise which is likely to affect prejudicially the control of my vehicle, I am prohibited from participating in the event and am obliged to declare such disability in writing to the The Sri Lanka Automobile Sports (SLAS) Or the Federation of Motor Cycle Sports (FMSSL) and to obtain from them at their discretion and following such declaration, a license which permits me to participate. I agree that all decisions and determination of the SLAS and FMSSL in this regard shall be final and binding, and that I shall not be entitled to bring and shall not prefer any claim, arbitration, lawsuit or other litigation against such decision or determination in any court or tribunal. I further acknowledge and agree that any dispute or disagreement I may be concerned with or may have or arise out of a decision made by the organisers on the basis of the rules and regulations, may be canvassed exclusively through the Appeal process as set out in the National Sporting Code (NSC) for final and binding arbitration. No dispute shall be referred by me to a Court or Tribunal or other similar forum. I undertake to adhere to and be bound by the Rules, Regulations and instruction governing the Meet which rules, Regulations and instructions I have read and understood.

Doping/Alcohol Control

I hereby voluntarily and irrevocably give my consent to allow a Doping Control/Alcohol Control Officer to examine me prior to, during or following a motor sporting event, meeting or competition. I further consent and agree that at any time before, during and after any event I shall cooperate with, facilitate and permit such examinations, a sample of my blood and/or urine to be taken for laboratory analysis by the Doping Control/Alcohol Control Officer concerned with determining the presence of alcohol or prohibited drugs as listed in the Anti-Doping Code, in accordance with the procedure for testing as prescribed by WADA (World Anti-Doping Agency) and Sri Lanka Anti-Doping Agency (SLADA). Should the analysis of the samples taken reveal the presence of alcohol or drugs or should I refuse to

allow samples of blood and/or urine to be taken, I consent to SLADA / CMSC/ SLMCC/ MRA / NMSC/ SMSC/ NMSC/ AMRC/Colombo MSC/ SLARDAR /SLAS / FMSSL, taking disciplinary action against me as envisaged in the NSC. I undertake to accept, agree to and abide by the decision of the Organizing Committee which, I concede, has the right to accept or reject any Entry at the Meet without assigning any reasons whatsoever and whose decision is final and binding.
